## Funds provide scholarships and assistance to many

The Community Foundation of Marquette County consists of over 150 funds that provide grants and scholarships to groups and individuals throughout Marquette County. One such fund is the Paul W. & Pearl K. Goodman Music Scholarship Fund. The Fund was established in 1998 with the purpose of providing the financial means for individual music lessons for talented youth between 3rd and 10th grade. Twelve promising students received up to \$750 for music lessons. One such talented student is Thomas McCollum. His instrument is the Great Highland Bagpipes and as he said in his application, "I hope to be a champion piper and this (scholarship) will help my parents afford my hobbies." Goodman Music Scholars will be expected to perform in at least one recital presented to the community to demonstrate their learning once their lessons are finished.

## **Grant for Hematites Building Better Neighborhoods**

The Greater Ishpeming Area Community Fund provided a \$1,500 grant to the Hematites Building Better Neighborhoods program. An additional \$1,000 was granted from the Marquette Fund. This enabled them to purchase a work trailer to store tools at the job site. This program is an extension of the previously funded 2013 Geometry in Construction program and aims to bring the learned construction skills of Ishpeming students out into the community.



## So Many Ways to Give

Turn stock market gains into community investment. Everybody wins when you make a gift of appreciated stock to your community foundation. Your gains are put to good use. Your gift of stock is reinvested in your community, and it qualifies for an immediate tax deduction based on the full market value.

### **Gift of Life Insurance**

Leave your community as your beneficiary. Life insurance provides a simple way for you to give a significant gift to charity, with tax benefits that you can enjoy during your lifetime.

### **Gift of Real Estate**

Making a charitable gift of real estate through your community foundation can help you turn your property gains into community good. The value of your real estate may exceed that of any other asset you own. With the help of your community foundation, you can use it to fulfill your charitable interests and receive financial tax benefits.
